## A. Regular Meeting Brief 9-13-16

The regular meeting brief for 9-13-16 was pulled from the consent agenda to make corrections. The correction made was to reflect Councilor Uffelman and Councilor Beebe as absent.

## B. Blue Zone – Muriel DeLaVerge-Brown / Holly Wenzel

Ms. DeLaVerge-Brown and Ms. Wenzel from the Crook County Health Department explained that Prineville has been selected as one of the final three for this designation. Representatives from the Blue Zone program will be here for the final in person interview next Thursday, October 6<sup>th</sup>. They encouraged as many as possible from the community to be there to show support.

#### **Council Business**

#### A. Downtown Strategic Planning Committee (DSP) Grants - Phil Stenbeck

Phil Stenbeck, Planning Director went through a power point presentation that highlighted some of the work proposed to be done with a match of up to \$2,500 for each application.

Mr. Stenbeck provided background information as to how the scoring worked, criteria for scoring and how the projects ranked, adding that the fifth project is a combined matched by the city as well as the Chamber of Commerce.

Councilor Carr added that it was a good process and that just by doing this has prompted other property owners to improve their properties.

Councilor Carr asked council to think about a replacement for himself on the DSPC to keep projects and momentum with this going.

Councilor Uffelman made a motion to approve the DSP Committee recommendation for the projects selected to move forward. Motion seconded. No discussion on motion. All in favor, motion carried.

## B. Discussion of Resolution Regarding Measure 97

Mayor Roppe explained that this discussion came up during the Community Renewable Energy Association (CREA) meeting.

Carl Dutli, City Attorney provided his findings of the council being able to do this if they choose, along with the guidelines in doing so.

Caroline Ervin, Prineville Economic Development Manager explained that EDCO has taken a stance again Measure 97.

Council agreed unanimously that they are against Measure 97 and would like to have a city resolution brought back to them.

## **Staff Reports and Requests:**

## A. Manager's Report – Steve Forrester

Mr. Forester reported: the wetlands ground preparation is complete and the seeding is moving along good: Combs Flat Road will be closed beginning October 2<sup>nd</sup>; the Crack Sealing project is City of Prineville

underway; East Third Street Sidewalk project is almost complete; he was asked to speak at the Redmond Rotary meeting and received a warm welcome; League of Oregon Cities (LOC) annual meeting is this week and he will be attending the LOC Board meeting; and we will be having a workshop before the next council meeting on our pavement condition index (PCI).

Mr. Stenbeck announced that Prineville will be one of two award recipients from Department of Land Conservation (DLCD) for public involvement in land use as it relates to all the work in marijuana.

Mr. Forrester added that staff getting together to get ahead of marijuana has been noticed statewide.

## B. NW Peters Road Extension Update - Phil Stenbeck

Mr. Stenbeck presented his staff report explaining how if this land use project is approved, NW Peters Road will be extended from Main Street closer to LaMonta Road, which is identified in the Transportation System Plan (TSP).

There were discussions regarding the alignment of Peters Road and how if a land use application came in for that area, we could get the sliver of land to straighten out that intersection with a possible signal.

#### **Ordinances:**

A. Ordinance No. 1225 - Related to Excluding Certain Persons from Public Property (SECOND READING) - Chief Cummins

Chief Cummins came forward to answer questions regarding appeal process; when the ordinance would take effect; the education component; if someone is excluded would it be from that one park or all; and this is to be used as a tool to curb behavioral problems.

There were no further questions.

Councilor Uffelman made a motion to approve Ordinance No. 1225 for the second presentation. Motion seconded. There were discussions on motion. All in favor, motion carried.

Chief Cummins added that any interest group that has questions on how it is working can come visit anytime and he can go over it with them.
