

ORDINANCE NO. 574

AN ORDINANCE TO LICENSE, TAX, AND REGULATE CERTAIN BUSINESSES, TRADES, EMPLOYMENTS, OCCUPATIONS AND CALLINGS WITHIN THE CITY OF PRINEVILLE, OREGON.

THE PEOPLE OF THE CITY OF PRINEVILLE, OREGON DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person or persons to peddle or hawk any goods, wares, merchandise, or other articles of trade, or for any transient vendor of goods, wares or merchandise to vend, sell or offer for sale, or solicit for orders for the sale of any goods, wares, merchandise or articles of trade, or for any person or persons to set up and operate for hire or charge any junk store, shooting gallery, merry-go-round, or any ring game, throwing games, pitching game or drawing game, where rings or balls are pitched or thrown, or where any trade article of merchandise or value is drawn or sought to be drawn by chance, or for any organ grinder, beggar, or street musician to ply their said vocations, or for any person, firm or corporation to set up card tables for the use of the public, within the corporate limits of the City of Prineville, Oregon, without first obtaining from the city recorder a license therefor.

*in any public place*

Section 2. The licenses to be paid by any person or persons setting up and engaging in or operating any of the businesses, trades, employments, occupations or callings mentioned in section one of this ordinance shall be as follows:

Peddler on foot with pack, package, parcel or basket, two dollars per day, or eight dollars per week.

Transient solicitor, two dollars per day, or eight dollars per week.

Peddler with cart, hack, wagon or other vehicle, two dollars per day, or eight dollars per week.

Peddler or transient vendor of merchandise who sets up and sells goods in any house, booth, store, tent or other place within said city, three dollars per day, or twelve dollars per week.

Hawkers shall pay a license of five dollars per day.

Pawn brokers shall pay a license of forty dollars per annum.

Junk dealers shall pay a license of twenty dollars per annum.

Proprietors of shooting galleries shall pay a license of two dollars per month.

Proprietors of merry-go-rounds shall pay a license of three dollars per day.

Operators of any public card tables shall pay a license of five dollars per month for each table

Proprietors of any ring game, throwing game, pitching game, or any drawing game where rings or balls are pitched, rolled or thrown, or where any article of merchandise or value is drawn or sought to be drawn by chance, shall pay a license of two dollars and fifty cents per day. Organ grinders, beggars and street musicians shall pay a license of one dollar and fifty cents per day.

Section 3. All persons shall be deemed within the meaning of this ordinance who shall vend, hawk or sell or solicit or offer to vend or sell their goods, stock or articles of trade, or otherwise ply their vocation by public outcry in any street or place within said city of Prineville; and any person or persons soliciting, vending or selling or offering to vend or sell goods or wares or merchandise in any house, booth, store, tent or public place within said city, who shall remain in said business in said city for a less period than ninety days, shall be considered a transient vendor of goods, wares and merchandise within the meaning of this ordinance.

Section 4. Any person wishing to obtain a license to carry on any business, trade, employment, occupation or calling mentioned in section one of this ordinance shall first pay to the City Recorder the amount of such license in lawful money of the United States; the City Recorder shall thereupon issue to such person the license, which license shall specify the name of the person

to whom it is issued, the business sought to be carried on thereunder, and the duration and time such license shall remain in effect, and the amount paid therefor; which license shall be signed and dated by the City Recorder.

Section 5. The City Recorder shall keep a record of all licenses issued under the provisions of this ordinance, which record must show the date, amount and duration of each license issued, to whom issued, and for what business or occupation.

Section 6. Any person violating any of the provisions of this ordinance shall upon conviction thereof before the Municipal Judge, be fined not less than two dollars nor more than one hundred dollars; or be imprisoned in the City Jail not less than one day nor more than thirty days.

Section 7. Ordinance No. 331 and any other ordinance or ordinances in conflict herewith are hereby repealed.
