

RESOLUTION NO. 780

A RESOLUTION IN THE MATTER OF THE ADOPTION OF A  
TRANSPORTATION SYSTEM PLAN REPORT FOR THE CITY OF PRINEVILLE

IT IS HEREBY RESOLVED by the Prineville City Council as follows:

1. The City Council specifically finds that:

(a) The City has recently received a Transportation System Plan (TSP) Report dated October 1994 as prepared by David Evans & Associates, Inc. and Public Financial Management, Inc. that makes certain recommendations concerning current and future transportation systems for the City and the surrounding urban area;

(b) The City is fully aware of the transportation problems existing within the City and the surrounding urban areas, and is aware that the implementation of certain recommendations of said TSP are paramount to the resolution of many of said problems;

(c) The City is also aware that said TSP was developed with citizen input from the community, and that said TSP has been reviewed by the Oregon Department of Transportation (ODOT) and Oregon Department of Land Conservation & Development (DLCD) for compliance with Statewide Transportation Planning Goal No. 12, and that relative thereto said TSP contains many findings and provisions that will constitute major components of the Transportation Element of the Urban Area Comprehensive Plan; and

(d) The City is cognant of the fact that the Urban Area Comprehensive Plan is currently undergoing the DLCD mandated Periodic Review Process and will, relative thereto, be totally revised and updated on or before July 1, 1995.


2. The City Council finds that it is imperative at this time that said TSP be adopted as a definitive guideline for many decisions regarding needed transportation improvements, and that said TSP be a guideline for related planning decisions until such time as the overall Comprehensive Plan is adopted with a specific Transportation Element contained therein.

NOW THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF PRINEVILLE THAT SAID TRANSPORTATION SYSTEM PLAN REPORT IS HEREBY ADOPTED AS AN INTERIM GUIDELINE FOR ALL TRANSPORTATION SYSTEM IMPROVEMENTS AND RELATED PLANNING DECISIONS UNTIL SUCH TIME AS THE OVERALL COMPREHENSIVE PLAN FOR THE PRINEVILLE URBAN AREA IS ADOPTED AND IMPLEMENTED, AND THAT THE TRANSPORTATION SYSTEM IMPROVEMENT PRIORITIES SET FORTH THEREIN SHALL BE THE ADOPTED PRIORITIES OF THE CITY UNTIL SUCH TIME AS SAID IMPROVEMENT

PRIORITIES ARE AMENDED AND SET FORTH WITHIN THE DULY ADOPTED  
TRANSPORTATION ELEMENT OF SAID OVERALL URBAN AREA COMPREHENSIVE  
PLAN.
