

RESOLUTION NO. 767

A RESOLUTION SETTING A PUBLIC HEARING ON THE QUESTION OF THE WITHDRAWAL OF CERTAIN REAL PROPERTIES IDENTIFIED IN "EXHIBITS A AND B" OF RESOLUTION NO. 765 AND "EXHIBITS A, B AND C" OF RESOLUTION NO. 766 FROM THE CROOK COUNTY VECTOR CONTROL AND ZONE II FIRE DISTRICTS

WHEREAS, certain real properties identified in "Exhibits A and B" of Resolution No. 765 and "Exhibits A, B and C" of Resolution No. 766 were annexed into the City of Prineville by said Resolutions No.s 765 and 766 on January 11, 1994 and January 25, 1994 respectively; and

WHEREAS, said properties are in the Crook County Vector Control and Zone II Fire Districts; and

WHEREAS, the City Council pursuant to ORS 222.524 is desirous of holding a public hearing on the question of withdrawal of the annexed properties from said districts.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF PRINEVILLE, OREGON, RESOLVE AS FOLLOWS:


Section 1. The City Council pursuant to ORS 222.524 directs that a public hearing shall be held on the question of withdrawal of those certain real properties identified in "Exhibits A and B" of Resolution No. 765 and "Exhibits A, B and C" of Resolution No. 766 attached hereto, from the Crook County Vector Control District and the Crook County Zone II Fire District.


Section 2. At the public hearing the City Council shall hear objections to the withdrawal and shall determine whether such withdrawal is in the best interest of the City.

Section 3. The public hearing shall be on the 8th day of February, 1994, at 7:00 p.m. at the Prineville City Hall, located at 400 East 3rd Street, Prineville, Crook County, Oregon.

Section 4. Notice of the date, time, place and purpose of the hearing shall be published once each week for two consecutive weeks prior to the date of the hearing in a newspaper of general circulation in the City and shall be posted in four public places in the City for a like period.
